7 **A Resolution appropriating grant funds received in prior awards from the U.S.**  
8 **Department of Housing and Urban Development (“HUD”) for the HOME Program and for**  
9 **the Community Development Block Grant (“CDBG”) Program, for a total net amount of**  
10 **\$472,448.82, for Fiscal Year 2011, for the Executive’s Department of Community and**  
11 **Economic Development and declaring an emergency**

13 WHEREAS, Resolution No’s. 2010-429 and 2009-391 accepted prior year HUD awards  
14 of CDBG and HOME funds, both of which have current balances available for Fiscal Year 2011;  
15 and

16 WHEREAS, CDBG and HOME funds provide for various housing services to assist low  
17 and moderate income persons within the County of Summit’s jurisdiction; and

19 WHEREAS, Resolution No’s. 2010-497 and 2011-032 appropriated certain HOME funds  
20 which must now be adjusted in order to best meet current needs; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that the  
23 appropriations and adjustments to existing appropriation of the aforementioned grant funds are  
24 necessary and in the best interest of the County of Summit;
