7 **A Resolution authorizing the County Executive to execute a collective bargaining**
8 **agreement between Ohio Council 8 and Local 1229 of the American Federation of State,**
9 **County and Municipal Employees, AFL-CIO, and the County Medical Examiner, for the**
10 **period 4/1/11 through 3/31/14, for the Executive, and declaring an emergency.**

12 WHEREAS, a collective bargaining agreement has been reached between the County
13 Medical Examiner and Ohio Council 8 and Local 1229 of the American Federation of State,
14 County and Municipal Employees, AFL-CIO, for the period 4/1/11 through 3/31/14; and

16 WHEREAS, this Council has determined by reviewing all pertinent information that it is
17 necessary and in the best interest of the County of Summit to authorize the County Executive to
18 execute the aforementioned collective bargaining agreement;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The County Executive is hereby authorized to execute a collective bargaining agreement
26 between Ohio Council 8 and Local 1229 of the American Federation of State, County and
27 Municipal Employees, AFL-CIO, and the County Medical Examiner, for the period 4/1/11
28 through 3/31/14.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit and for the for the further purpose of providing a
34 timely collective bargaining agreement between Ohio Council 8 and Local 1229 of the American
35 Federation of State, County and Municipal Employees, AFL-CIO, and the County Medical
36 Examiner.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.

47 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
48 deliberations of this Council and of any of its committees that resulted in such formal action,
