29 to execute such a contract.

34 safety, and welfare of the citizens of the County of Summit and for the further reason of
35 immediately providing such services.

40 take effect immediately upon its adoption and approval by the Executive; otherwise, it
41 shall take effect and be in force at the earliest time provided by law.
