12 service contract with Quality Control Inspection, Inc., for construction inspection services, in an
13 amount not to exceed \$50,000.00, subject to confirmation by County Council; and

16 the aforementioned contract is necessary and in the best interest of the County of Summit;

18 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

23 The award by the Board of Control of a professional service contract with Quality
24 Control Inspection, Inc., for construction inspection services, in an amount not to exceed
25 \$50,000.00, is hereby confirmed and the County Executive is hereby authorized to execute such
26 contract renewal.

30 This Resolution is hereby declared an emergency in the interest of the health, safety and
31 welfare of the citizens of the County of Summit, and for the further reason to immediately
32 provide necessary construction inspection services to the County Engineer.

36 Provided this Resolution receives the affirmative vote of eight members, it shall take
37 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
38 effect and be in force at the earliest time provided by law.

43 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
44 deliberations of this Council and of any of its committees that resulted in such formal action,


