7 **A Resolution confirming an award by the Board of Control of a change order to a**
8 **professional service contract with Tri-County Jobs for Ohio's Graduates for Workforce**
9 **Investment Act "Next Step" youth-based employment services, for the period 7/1/11 to**
10 **9/30/11, in an amount not to exceed \$90,000.00 (25%) for a total cumulative amount of**
11 **\$450,000.00, for the Executive's Department of Job and Family Services, and declaring an**
12 **emergency.**

14 WHEREAS, the Board of Control, at its meeting held June 1, 2011, awarded a change
15 order to provide the aforementioned services, subject to confirmation by County Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the change order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a change order to a professional service contract
26 with Tri-County Jobs for Ohio's Graduates for Workforce Investment Act "Next Step" youth-
27 based employment services, for the period 7/1/11 to 9/30/11, in an amount not to exceed
28 \$90,000.00 (25%) for a total cumulative amount of \$450,000.00, is hereby confirmed and the
29 County Executive is hereby authorized to execute such contract renewal.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further reason to immediately
35 provide the aforementioned services.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
