8 **elevator maintenance agreement for the Executive's Department of Job and Family**

10 **total cost not to exceed \$70,000.00, for the Executive's Department of Administrative**
11 **Services-Physical Plants, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for a five-year full
17 elevator maintenance agreement for the Executive's Department of Job and Family Services
18 Truth Building, Building 2 and Building 3, in Council District 4, for an estimated total cost not to
19 exceed \$70,000.00; and

21 WHEREAS, a copy of the bid package is on file in the office of the Clerk of Council; and

23 WHEREAS, this Council has determined by reviewing all pertinent information that is
24 necessary and in the best interest of the County of Summit to authorize the Executive to advertise
25 for bids for the aforementioned agreement;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

32 The County Executive is authorized to advertise for bids for a five-year full elevator
33 maintenance agreement for the Executive's Department of Job and Family Services Truth
34 Building, Building 2 and Building 3, in Council District 4, for an estimated total cost not to
35 exceed \$70,000.00.

39 This Resolution is declared an emergency in the interest of the health, safety, and welfare
40 of the citizens of the County of Summit, and for the further reason that it immediately authorizes
41 the Executive to advertise for bids for a five-year full elevator maintenance service agreement for
42 the Executive's Department of Job and Family Services Truth Building, Building 2 and Building
43 3, in Council District 4, in order to meet appropriate deadlines for this contract.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


