13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for the County of Summit
17 Children Services Board temperature control upgrade project at its facility located at 264 South
18 Arlington Street, Akron, Ohio 44306, in Council District 4, for an estimated total cost not to
19 exceed \$160,000.00; and

21 WHEREAS, a copy of the bid package is on file in the office of the Clerk of Council; and

23 WHEREAS, the cost of the aforementioned contract shall be paid for by Children
24 Services Board funds; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that is
27 necessary and in the best interest of the County of Summit to authorize the Executive to advertise

43 of the citizens of the County of Summit, and for the further reason that it authorizes the

46 Ohio 44306, in Council District 4, in order to meet appropriate deadlines for this project.
