7 **A Resolution authorizing the County Executive to advertise for bids for a five-year full**  
8 **maintenance service agreement for the Executive's Department of Job and Family Services**  
9 **heating, ventilation and air conditioning systems, in Council District 4, for an estimated**  
10 **total cost not to exceed \$300,000.00, for the Executive's Department of Administrative**  
11 **Services-Physical Plants, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit  
14 requires this Council's authorization for the County Executive to advertise for bids; and

15  
16 WHEREAS, the County Executive wishes to advertise for bids for a five-year full  
17 maintenance service agreement for the Executive's Department of Job and Family Services  
18 heating, ventilation and air conditioning systems, in Council District 4, for an estimated total cost  
19 not to exceed \$300,000.00; and

21 WHEREAS, a copy of the bid specifications is on file in the office of the Clerk of  
22 Council; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that is  
25 necessary and in the best interest of the County of Summit to authorize the Executive to advertise  
26 for bids for the aforementioned agreement;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

33 The County Executive is authorized to advertise for bids for a five-year full maintenance  
34 service agreement for the Executive's Department of Job and Family Services heating,  
35 ventilation and air conditioning systems, in Council District 4, for an estimated total cost not to  
36 exceed \$300,000.00.

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
41 of the citizens of the County of Summit, and for the further reason that it immediately authorizes  
42 the Executive to advertise for bids for a five-year full maintenance service agreement for the  
43 Executive's Department of Job and Family Services heating, ventilation and air conditioning  
44 systems, in Council District 4, in order to meet appropriate deadlines for this contract.

49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
50 effect and be in force at the earliest time provided by law.
