7 **A Resolution authorizing the Executive to execute subscriber agreements with West, A**  
8 **Thomson Reuters Business, ("West") for WestlawNext legal research software to be**  
9 **provided to the Ninth District Court of Appeals and the Prosecutor, for the Ninth District**  
10 **Court of Appeals and the Prosecutor, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held June 22, 2011, awarded a contract  
13 to West to provide WestlawNext legal research software to the Ninth District Court of Appeals,  
14 pursuant to the terms set forth on Exhibit A, subject to confirmation by County Council; and,

16 WHEREAS, the Prosecutor has requested that this Council authorize the Executive to  
17 execute, subject to the approval of the Board of Control, a contract with West to provide  
18 WestlawNext legal research software to the Prosecutor, pursuant to the terms set forth on Exhibit  
19 A; and

21 WHEREAS, County Council has determined by reviewing all pertinent information that  
22 the contract is necessary and in the best interest of the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

27 SECTION 1

29 The Executive is hereby authorized to execute subscriber agreements with West for  
30 WestlawNext legal research software to be provided to the Ninth District Court of Appeals and  
31 the Prosecutor, pursuant to the terms set forth on Exhibit A, provided that the approval of the  
32 agreement with the Prosecutor is subject to the award of the Board of Control.

34 SECTION 2

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
38 provide the aforementioned software.

40 SECTION 3

42 Provided this Resolution receives the affirmative vote of eight members, it shall take  
43 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
44 effect and be in force at the earliest time provided by law.

46 SECTION 4

48 It is found and determined that all formal actions of this Council concerning and relating  
49 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
50 deliberations of this Council and of any of its committees that resulted in such formal action,  
51 were in meetings open to the public, in compliance with all legal requirements, including Section  
52 121.22 of the Ohio Revised Code.


