7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire a**  
9 **full-time unclassified Director of Administration, at the rate of \$28.55 per hour, the**  
10 **minimum pay rate for the position, for the Executive, and declaring an emergency.**

11  
12 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted  
13 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled  
14 "Temporary Hiring Freeze," as a budgetary control measure; and

15  
16 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
17 the filling of an existing position by hiring an employee is necessary for the effective and  
18 continued operation of the office, Council may adopt a Resolution authorizing the office to hire  
19 said employee; and

20  
21 WHEREAS, due to separation through resignation of a full-time unclassified Director of  
22 Administration, the County Prosecutor states that it is necessary for the continued and effective  
23 operation of her office to be permitted to hire and fill this vacancy with a full-time unclassified  
24 Director of Administration, at the rate of \$28.55 per hour, the minimum pay rate for the position;

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
28 necessary and in the best interest of the County of Summit to authorize the Prosecutor to hire a  
29 full-time unclassified Director of Administration, at the rate of \$28.55 per hour, the minimum  
30 pay rate for the position;

32 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
33 that:

35 SECTION 1

37 County Council hereby determines that it is necessary for the continued and effective  
38 operation of the County Executive's Office, and further authorizes the County Prosecutor to hire  
39 externally a full-time unclassified Director of Administration, at the rate of \$28.55 per hour, the  
40 minimum pay rate for the position.

42 SECTION 2

43  
44 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
45 and welfare of the citizens of the County of Summit and for the further reason that it is necessary  
46 to immediately authorize the hiring of the aforementioned position.

48 SECTION 3

50 Provided this Resolution receives the affirmative vote of eight members, it shall take  
51 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect  
52 and be in force at the earliest time provided by law.


