7 **A Resolution authorizing the County Executive to execute a contract with Oriana House,**  
8 **Inc., and the County Sheriff for the operation of a community corrections program for**  
9 **State Fiscal Year (“SFY”) 2012, the period July 1, 2011 through June 30, 2012, in the**  
10 **amount of \$448,759.00, which is funded by a 408 Grant through the Community**  
11 **Corrections Act (“CCA”), pursuant to which Oriana House, Inc. shall be paid an amount**  
12 **not to exceed \$359,405.00 and the County Sheriff shall be paid an amount not to exceed**  
13 **\$89,354.00, for the Executive’s Department of Law, Division of Public Safety—Justice**  
14 **Affairs, and declaring an emergency.**

15  
16 WHEREAS, the State of Ohio Department of Rehabilitation and Correction through the  
17 Community Corrections Act (“CCA”) has renewed the award to the County of Summit of a 408  
18 Grant for State Fiscal Year 2012, in the amount of \$448,759.00, with no local cash match  
19 requirement, for a community corrections program to be operated by the County Sheriff and  
20 Oriana House, Inc., for the period of July 1, 2011 through June 30, 2012; and

22 WHEREAS, this Council previously adopted Resolution No. 2011-173, which authorized  
23 the County Executive to execute any documents necessary to accept the aforementioned 408  
24 Grant and appropriated grant funds; and

26 WHEREAS, it is necessary for this Council to authorize the Executive to execute a  
27 contract with Oriana House, Inc. and the County Sheriff for the operation of a community  
28 corrections program for SFY 2012, in the amount of \$448,759.00, which is funded by the  
29 aforementioned 408 Grant through the CCA, pursuant to which Oriana House, Inc. shall be paid  
30 an amount not to exceed \$359,405.00 and the County Sheriff shall be paid and amount not to  
31 exceed \$89,354.00; and

33 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
34 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
35 the aforementioned contract;

37 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
38 of Ohio, that:

42 The County Executive is hereby authorized to execute a contract with Oriana House, Inc.  
43 and the County Sheriff for the operation of a community corrections program for State Fiscal  
44 Year (“SFY”) 2012, the period July 1, 2011 through June 30, 2012, in the amount of  
45 \$448,759.00, which is funded by a 408 Grant through the Community Corrections Act (“CCA”),  
46 pursuant to which Oriana House, Inc. shall be paid the amount an amount not to exceed  
47 \$359,405.00 and the County Sheriff shall be paid an amount not to exceed \$89,354.00.

6 This Resolution is declared an emergency in the interest of the health, safety and welfare  
7 of the citizens of the County of Summit and for the further purpose of immediately authorizing  
8 the Executive to execute a contract with Oriana House, Inc. and County Sheriff for the operation  
9 of a community corrections program for SFY 2012, which is funded by the 408 Grant through  
10 the CCA.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take  
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
16 effect and be in force at the earliest time provided by law.


