7 **A Resolution authoring the Executive to execute an agreement, through the Executive's**  
8 **Department of Job and Family Services, with the County of Summit Combined General**  
9 **Health District, County of Summit Children Services Board, County of Summit Board of**  
10 **Developmental Disabilities and the County of Summit Alcohol, Drug Addiction and Mental**  
11 **Health Services Board, for the continued operation and management of the Summit 2020**  
12 **Quality of Life Project, for the period 1/1/11 through 12/31/12, for the Executive's**  
13 **Department of Job and Family Services, and declaring an emergency.**

14  
15 WHEREAS, from 2002 to 2010, the County of Summit Social Services Advisory Board  
16 ("SSAB") has operated the Summit 2010 Quality of Life Project, with the aim of building  
17 collaboration between hundreds of public and nonprofit health and social service providers to  
18 assure that the needs of the most vulnerable citizens of Summit County are addressed  
19 consistently, professionally and effectively; and

20  
21 WHEREAS, from 2002 to 2010, the Summit 2010 Quality of Life Project collected data  
22 for 20 indicators of health and social service quality in Summit County, developed plans and  
23 goals to improve these 20 indicators, implemented those plans to strengthen the public health and  
24 social service infrastructure and formed collaborations between the major public health and  
25 social services providers and systems in order to increase the effectiveness of services they  
26 deliver; and

27  
28 WHEREAS, from 2002 to 2010, the County first hired a consultant to manage the 2010  
29 Quality of Life Project, with the County, through the Executive's Department of Job and Family  
30 Services ("DJFS"), County of Summit Children Services Board ("CSB"), County of Summit  
31 Board of Developmental Disabilities ("DD Board") and the County of Summit Alcohol, Drug  
32 Addiction and Mental Health Services Board ("ADM Board"), entering into an agreement to  
33 share in the cost of said consultant, and the County of Summit Combined General Health District  
34 ("Health District") subsequently assuming the responsibility for managing the project in 2009  
35 and 2010 pursuant to an agreement between the parties; and

36  
37 WHEREAS, as the manager of the Summit 2010 Quality of Life Project, the Health  
38 District has been compensated by the other parties to this agreement, and also has contributed in-  
39 kind services to the project; and

40  
41 WHEREAS, the County, CSB, DD Board, ADM Board and Health District have  
42 determined that the Summit 2010 Quality of Life Project is beneficial to the major objectives of  
43 each party, assists each party in improving services to and quality of life of the parties'  
44 respective clientele and addresses the health, social and quality of life issues facing Summit  
45 County; and

47 WHEREAS, the County, CSB, DD Board, ADM Board and Health District have  
48 determined that it is beneficial to each of them and Summit County as a whole to continue the  
49 Summit 2010 Quality of Life Project for the next decade and to rename the project the Summit  
50 2020 Quality of Life Project; and

4 WHEREAS, the Health District desires to continue to manage, and the County, CSB, DD  
5 Board and ADM Board desire the Health District to continue to manage, the Summit 2020  
6 Quality of Life Project, pursuant to the an agreement between the parties; and

7  
8 WHEREAS, the primary objective of the 2020 Quality of Life Project will be to develop  
9 and implement initiatives in five main areas to improve public health and social service delivery:  
10 (i) Economic Stability and Prosperity, (ii) First Things First, (iii) Older Adults, (iv) Health and  
11 Health Disparities, and (v) Government Efficiency and Effectiveness; and

12  
13 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
14 that it is necessary and in the best interest of the County to authorize the Executive to enter into  
15 an agreement with the Health District, CSB, DD Board and ADM Board for the continued  
16 operation and management of the Summit 2020 Quality of Life Project for the period 1/1/11  
17 through 12/31/12;

19 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
20 that:

22 SECTION 1

23  
24 The Executive is hereby authorized to execute an agreement, through the Executive's  
25 Department of Job and Family Services ("DJFS"), the County of Summit Combined General  
26 Health District ("Health District"), County of Summit Children Services Board ("CSB"), County  
27 of Summit Developmental Disabilities Board ("DD Board"), and the County of Summit Alcohol,  
28 Drug Addiction and Mental Health Services Board ("ADM Board"), for the continued operation  
29 and management of the Summit 2020 Quality of Life Project for the period of 1/1/11 through  
30 12/31/12, a copy of said agreement being attached hereto as Exhibit A. Furthermore, funds for  
31 the County's financial obligations under the aforementioned agreement shall be paid through  
32 funds appropriated for use by the Executive's Department of Job and Family Services ("DJFS").

34 SECTION 2

36 This Resolution is hereby declared an emergency in the interest of the health, safety, and  
37 welfare of the citizens of the County of Summit and for the further reason of immediately  
38 authorizing the execution of said agreement to ensure the continued operation and management  
39 of the 2020 Quality of Life Project.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
