8 **maintenance service agreement for the fire alarm, door control and card access at the**

10 **for an estimated total cost not to exceed \$200,000.00, for the Executive's Department of**
11 **Administrative Services – Physical Plants, and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for a five-year full
17 maintenance service agreement for the fire alarm, door control and card access at the County of
18 Summit Jail, 205 East Crosier Street, Akron, Ohio 44311, in Council District 4, for an estimated
19 total cost not to exceed \$200,000.00; and

24 authorizing the County Executive to advertise for bids for the aforementioned agreement is

39 This Resolution is declared an emergency in the interest of the health, safety, and welfare
40 of the citizens of the County of Summit, and for the further reason that it authorizes the
41 Executive to immediately advertise for bids for the aforementioned agreement.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
