7 **A Resolution authorizing the County Executive to enter into a three-year policing**
8 **agreement with the Township of Northfield Center, Council District 1, to provide 5.5**
9 **Sheriff's deputies, for the period 1/1/12 to 12/31/14, in the amount of \$586,316.67 for the**
10 **first year, \$593,033.33 for the second year, and \$596,582.00 for the third year, for a total**
11 **amount not to exceed \$1,775,932.00 during the three-year term of the agreement, for the**
12 **Sheriff, and declaring an emergency.**

14 WHEREAS, the Executive entered into a policing contract with the Township of Northfield
15 Center which terminates 12/31/11; and

16
17 WHEREAS, the Township of Northfield Center hereby requests that the Executive enter
18 into a new agreement to provide 5.5 Sheriff's deputies for the period 1/1/12 to 13/31/14; and

20 WHEREAS, the Township of Northfield Center has agreed to pay the County \$586,316.67
21 for the first year, \$593,033.33 for the second year, and \$596,582.00 for the third year, for a total
22 amount not to exceed \$1,775,932.00 during the three-year term of agreement; and

24 WHEREAS, this Council has determined by reviewing all pertinent information that
25 authorizing the Executive to execute the aforementioned agreement is necessary and in the best
26 interest of the County of Summit;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
29 of Ohio, that;

31 SECTION 1

33 The County Executive is hereby authorized to enter into a three-year policing agreement
34 with the Township of Northfield Center, Council District 1, to provide 5.5 Sheriff's deputies for
35 the period 1/1/12 to 12/31/14, in the amount of \$586,316.67 for the first year, \$593,033.33 for
36 the second year, and \$596,582.00 for the third year, for a total amount of \$1,775,932.00 during
37 the three-year term of the agreement.

41 This Resolution is hereby declared an emergency in the interest of the health, safety and
42 welfare of the citizens of the County of Summit and for the further purpose of immediately
43 authorizing an agreement to provide necessary policing for the Township of Northfield Center
44 for 2012.

48 Provided this Resolution receives the affirmative vote of eight members, it shall take
49 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
50 effect and be in force at the earliest time provided by law.
