14 contract to provide the aforementioned services, subject to confirmation by County Council; and,

17 the contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

24 The award by the Board of Control of a professional service contract with Tri-County
25 Jobs for Ohio Graduates for the second and final renewal for WIA Next Step youth-based
26 employment services, for the period 10/1/11 to 6/30/12, in an amount not to exceed \$270,000.00,
27 is hereby confirmed and the County Executive is hereby authorized to execute such contract.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further purpose to immediately
33 provide the aforementioned services.

38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
