7 **A Resolution authorizing the Executive to enter into an agreement with the Village of**  
8 **Lakemore whereby the County Engineer will provide general services to the Village of**  
9 **Lakemore, in Council District 8, for the Engineer, and declaring an emergency.**

11 WHEREAS, Section 302.21 of the Ohio Revised Code provides that the County  
12 Executive, with the consent of this Council, may enter into a contract with a municipality,  
13 whereby the County agrees to perform one of that municipality's functions on behalf of the  
14 municipality; and

15  
16 WHEREAS, the County may designate within said agreement which County office will  
17 perform the County's responsibilities under the agreement; and

18  
19 WHEREAS, pursuant to Section 302.21 of the Ohio Revised Code, this Council wishes  
20 to enter into an agreement with the Village of Lakemore ("Lakemore") whereby the County will  
21 provide general services, other than snow and ice control, to Lakemore and Lakemore will pay  
22 the County for the same; and

23  
24 WHEREAS, within said agreement, this Council wishes to designate the County  
25 Engineer as the County office to perform the general services required to Lakemore; and

26  
27 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
28 necessary and in the best interest of the County of Summit to authorize the Executive to enter  
29 into an agreement with Lakemore whereby the County Engineer will perform general services  
30 for Lakemore;

32 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State  
33 of Ohio, that;

35 SECTION 1

36  
37 The County Executive is hereby authorized to execute an agreement with the Village of  
38 Lakemore ("Lakemore"), whereby the County Engineer will provide general services to  
39 Lakemore. A copy of said agreement is attached hereto as Exhibit A.

41 SECTION 2

43 This Resolution is hereby declared an emergency in the interest of the health, safety and  
44 welfare of the citizens of the County of Summit, and for the further purpose to immediately  
45 allow the Executive to execute said agreement and allow the Engineer to begin immediately  
46 begin providing general services to Lakemore.

8 effect and be in force at the earliest time provided by law.


