7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Ohio Emergency Management Agency of a State Fiscal Year 2012**  
9 **Statewide Search and Rescue Capability grant, for the period 7/1/11 through 6/30/12, in the**  
10 **amount of \$10,000.00, with no local cash match requirement, and appropriating these**  
11 **funds for Region 5 expenditures through 6/30/12, for the Executive’s Department of Law,**  
12 **Insurance and Risk Management - Public Safety/Emergency Management Agency, and**  
13 **declaring an emergency.**

15 WHEREAS, the Ohio Emergency Management Agency has granted a State Fiscal Year  
16 2012 Statewide Search and Rescue Capability grant award in non-federal funds, in the amount of  
17 \$10,000.00, for the period 7/1/11 through 6/30/12, with no local cash match requirement, to the  
18 County of Summit Emergency Management Agency; and

20 WHEREAS, the purpose of the grant is to support Ohio urban search and rescue  
21 programs around the state to create a stronger search and rescue capability statewide and will be  
22 utilized to continue to build and sustain the Region 5 Type II collapse search and rescue  
23 capability; and

25 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
26 necessary and in the best interest of the County of Summit to authorize the Executive to execute  
27 any documents necessary to accept the award of the aforementioned grant from the Ohio  
28 Emergency Management Agency for State Fiscal Year 2012, and to appropriate these search and  
29 rescue grant funds;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

36 The County Executive is hereby authorized to execute any documents necessary to accept  
37 the State Fiscal Year 2012 Statewide Search and Rescue Capability grant award from the Ohio

39 \$10,000.00, with no local cash match requirement.
