7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a Temporary Assistance to Needy Families ("TANF") award of federal funds from**
9 **the County of Summit Department of Job and Family Services ("SCDJFS"), for the Family**
10 **Resource Center ("FRC"), in the amount of \$340,000.00, with no local cash match**
11 **requirement, with a performance period of 10/1/11 through 9/30/12, and appropriating**
12 **these funds through 12/31/11, for the Juvenile Court, and declaring an emergency.**

13
14 WHEREAS, the County of Summit Juvenile Court has received an award of federal
15 funds, in the amount of \$340,000.00, with no local cash match requirement, from SCDJFS for a
16 TANF FRC program, for the period 10/1/11 through 9/30/12; and

18 WHEREAS, the FRC program provides families with intensive case management to at-
19 risk youth who are involved in any of the following situations: domestic violence, pregnancy, are
20 parenting teens, teens at risk of dropping out of school, and/or returning from long stays at the
21 detention center or other placement center; and

23 WHEREAS, the FRC program also provides resources for other court-involved youth,
24 and the County as a whole, being the central point of referral for all services available throughout
25 the County for youth and their families; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is
28 necessary and in the best interest of the County of Summit to authorize the Executive to execute
29 any documents necessary to accept the award of the aforementioned grant from SCDJFS, and to
30 appropriate these grant funds;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
33 of Ohio, that:

37 The County Executive is hereby authorized to execute any documents necessary to accept
38 a Temporary Assistance to Needy Families ("TANF") award of federal funds from the County of
39 Summit Department of Job and Family Services ("SCDJFS"), for the Family Resource Center
40 ("FRC"), in the amount of \$340,000.00, with no local cash match requirement, with a
41 performance period of 10/1/11 through 9/30/12.

34 121.22 of the Ohio Revised Code.


