7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**
9 **one external person into a part-time, non-bargaining, classified Student Helper position, to**
10 **work in the Victim Services unit of the Juvenile Division of the Prosecutor's Office, at a**
11 **rate not to exceed \$10.13 per hour, for an estimated cost for the part-time position of**
12 **\$12,043.00 annually; for the Prosecutor, and declaring an emergency.**

14 WHEREAS, this Council previously adopted Ordinance No. 2009-110, which enacted
15 Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled "Temporary
16 Hiring Freeze," to control and reduce the County's budget deficit, and Ordinance No. 2011-204,
17 which reinstated the hiring freeze through December 31, 2012; and

19 WHEREAS, Section 169.04(j) of the Codified Ordinances of the County of Summit
20 provides that if a County office is able to demonstrate that the filling of an existing position by
21 hiring an employee is necessary for the effective and continued operation of the office, Council
22 may adopt a Resolution authorizing the office to hire said employees; and

24 WHEREAS, due to separation through resignation, it is necessary for the continued and
25 effective operation of the Prosecutor's Office to be permitted to hire and fill a part-time Student
26 Helper position, which is an entry-level position within the Prosecutor's Office, at a rate not to
27 exceed \$10.13 per hour, for an estimated cost for the part-time position of \$12,043.00 annually;

30 WHEREAS, this Council has determined, by reviewing all pertinent information that it is
31 necessary and in the best interest of the County of Summit to authorize the County Prosecutor to
32 hire an external person into a part-time, non-bargaining, classified Student Helper position.

34 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
35 State of Ohio, that:

39 County Council hereby determines that the County Prosecutor has demonstrated that it is
40 necessary for the effective and continued operation of her office to authorize the County
41 Prosecutor, pursuant to Section 169.04(j) of the Codified Ordinances of the County of Summit,
42 to hire an external person into a part-time, non-bargaining, classified Student Helper position, at
43 a rate not to exceed \$10.13 per hour, for an estimated cost for the part-time position of
44 \$12,043.00 annually.

48 This Resolution is hereby declared an emergency in the interest of the health, safety and
49 welfare of the citizens of the County of Summit and for the further reason to immediately
50 authorize the County Prosecutor to hire an external person into a part-time, non-bargaining,
51 classified Student Helper in order to continue effectively prosecuting cases and collect revenue
52 for the County of Summit.


