7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Public Safety - Office of Criminal Justice, for**
9 **a countywide Operating a Motor Vehicle While Intoxicated (“OVI”) Task Force program, in**
10 **the amount of \$198,449.88, in federal funds, with no local cash match requirement, for the**
11 **period 10/1/11 through 9/30/12, and appropriating all grant funds for the period 10/1/11**
12 **through 12/31/11, for the Sheriff, and declaring an emergency.**

14 WHEREAS, the Ohio Department of Public Safety, through the Office of Criminal Justice
15 Services, has awarded the County of Summit Sheriff federal funding for a countywide OVI Task
16 Force program for federal fiscal year 2012; and

18 WHEREAS, it is necessary and in the best interest of the County of Summit to appropriate
19 all grant funds for the period 10/1/11 through 12/31/11; and

21 WHEREAS, the Sheriff has been awarded \$198,449.88, with no local cash match
22 requirement, for the countywide OVI Task Force program in order to conduct high visibility
23 enforcement, public awareness, and education for alcohol-related crashes and traffic-related
24 fatalities in the County of Summit, for the period 10/1/11 through 9/30/12; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to authorize the County Executive to
28 execute any documents necessary to accept the aforementioned grant and to appropriate grant
29 funds;

31 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of
32 Ohio, that:

36 The County Executive is hereby authorized to execute any documents necessary to accept a
37 grant award in the amount of \$198,449.88 in federal funding, with no local cash match
38 requirement, from the Ohio Department of Public Safety - Office of Criminal Justice Services, for
39 a countywide Operating a Motor Vehicle While Intoxicated (“OVI”) Task Force program, for the
40 period 10/1/11 through 9/30/12.
