7 **A Resolution appropriating a new award of federal Workforce Investment Act ("WIA")**
8 **funds, in the amount of \$150,000.00, and carryover WIA funds, in the amount of**
9 **\$25,000.00, for a total of \$175,000.00, with no local cash match requirement, for the Youth**
10 **Employment for Success ("YES") program, received from the Executive's Department of**
11 **Job and Family Services ("DJFS"), for the period 10/1/11 through 6/30/12, for the**
12 **Executive's Department of Communications - YES, and declaring an emergency.**

14 WHEREAS, Resolution No. 2011-368 confirmed the award by the Board of Control of a
15 professional service contract funded by a WIA grant in the amount of \$150,000.00 and awarded
16 by the County Executives' Department of Job and Family Services to the County of Summit
17 YES program, for the period 10/1/11 through 6/30/12; and

19 WHEREAS, the YES program has a carryover balance of \$25,000.00 in WIA funds
20 appropriated in Resolution No. 2011-288; and

22 WHEREAS, the youth employment program's object is to assist youth in overcoming
23 barriers and achieving academic and career goals by addressing their needs for work experience,
24 academic support, leadership development, personal guidance, and follow up services; and

26 WHEREAS, this Council has determined by reviewing all pertinent information that it is
27 necessary and in the best interest of the County of Summit to appropriate the aforementioned
28 funds in the amount of \$175,000.00;

19 effect and be in force at the earliest time provided by law.


