7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Simplex Grinnell, LP, for five-year full maintenance services for fire alarm, door control**

13 WHEREAS, the Board of Control, at its meeting held October 19, 2011, awarded a
14 purchase contract to provide the aforementioned services, subject to confirmation by County
15 Council; and,

17 WHEREAS, County Council has determined by reviewing all pertinent information that
18 the purchase contract is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

25 The award by the Board of Control of a purchase contract with Simplex Grinnell, LP, for
26 five-year full maintenance services for fire alarm, door control and card access at the County of
27 Summit Jail, in Council District 4, in an amount not to exceed \$188,000.00, is hereby confirmed
28 and the County Executive is hereby authorized to execute such purchase contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.


