12 approved the 2011 operating budget for the County of Summit, which approved appropriations
13 for the Child Support Enforcement Fund; and

15 WHEREAS, the appropriation requires a reduction totaling \$632,000.00 due to reduced
16 federal funding as a result of the Deficit Reduction Act of 2005; and

18 WHEREAS, this Council has determined by reviewing all pertinent information that the
19 aforementioned appropriation decrease to the 2011 budget is necessary and in the best interest of
20 the County of Summit;

8 effect and be in force at the earliest time provided by law.


