7 **A Resolution appropriating additional funds received in federal demonstration grant**
8 **funds, with budget year of 9/1/11 through 8/31/12, from the U.S. Department of Health and**
9 **Human Services, Office of Child Support Enforcement (“USOCSE”), in the amount of**
10 **\$50,000.00, with no local cash match requirement, for the Special Improvement Program,**
11 **for the Prosecutor’s Child Support Enforcement Agency (“CSEA”), and declaring an**
12 **emergency.**

13
14 WHEREAS, CSEA has received additional federal funding for an existing demonstration
15 grant, in the amount of \$50,000.00, with no local cash match requirement, for a budget period of
16 9/1/11 through 8/31/12, from the USOCSE for the Special Improvement Program, a diversion
17 program that supports the entire family including both custodial and non-custodial parents; and

18
19 WHEREAS, the USOCSE grant was originally awarded and appropriated in Resolution
20 No. 2010-449 to be used for salaries, benefits and other operating costs for an Outreach
21 Coordinator to run the diversion program in partnership with the County of Summit Domestic
22 Relations Court, Workforce Development, local fatherhood initiatives, and The University of
23 Akron; and

25 WHEREAS, the Special Improvement Program and efforts to divert civil contempt
26 findings for non-payment of support actually improves the likelihood that parents will pay their
27 support; and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is
30 necessary and in the best interest of the County of Summit to appropriate the aforementioned
31 funds, in the amount of \$50,000.00;
