24 The award by the Board of Control of a purchase order with Graphic Enterprises, Inc., for
25 the renewal of copier maintenance for 30 machines, for the period 11/1/11 to 10/31/12, in an
26 amount not to exceed \$25,624.51, is hereby confirmed and the County Executive is hereby
27 authorized to execute such purchase order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the citizens of the County of Summit, and for the further reason to immediately
33 provide the aforementioned maintenance.

38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.
