15 contract to provide the aforementioned agreement, subject to confirmation by County Council;

19 the contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

26 The award by the Board of Control of a professional service contract with the County
27 Commissioners Association of Ohio and Ohio Child Support Enforcement Agency Director's
28 Association, for a participation agreement for employment verification services, for the period
29 7/1/11 to 6/30/12, with five options to renew for a one-year period, in an amount not to exceed
30 \$56,074.29, is hereby confirmed and the County Executive is hereby authorized to execute such
31 contract.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and
36 welfare of the citizens of the County of Summit, and for the further purpose to immediately
37 provide the aforementioned agreement.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
