7 **An amended Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the**  
8 **County of Summit, entitled "Temporary Hiring Freeze," to authorize the County**  
9 **Executive to hire two external persons into part-time, bargaining unit, ~~unclassified~~**  
10 **classified, Computer Monitor Aide positions at the Department of Environmental Services,**  
11 **at an hourly rate not to exceed \$12.49, for the Executive's Department of Environmental**  
12 **Services, and declaring an emergency.**

13  
14 WHEREAS, County Council previously adopted Ordinance No. 2009-110, which  
15 enacted Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled  
16 "Temporary Hiring Freeze," to control and reduce the County's budget deficit, and Ordinance  
17 No. 2011-204, which reinstated the hiring freeze through December 31, 2012; and

18  
19 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
20 the filling of an existing position by hiring an employee is necessary for the effective and  
21 continued operation of the office, Council may adopt a resolution authorizing the office to hire  
22 said employees; and

24 WHEREAS, at the County Executive's Department of Environmental Services  
25 ("DOES"), one part-time employee in the part-time, bargaining unit, ~~unclassified~~ classified  
26 position of Computer Monitor Aide has resigned to take a full-time position at the Department of  
27 Job and Family Services and another person previously employed in that position has left County  
28 employment; and

30 WHEREAS, the County Executive states that two available positions of Computer  
31 Monitor Aide has been posted internally and that his office has not been able to hire a qualified  
32 candidate into either position and that it is necessary for the continued and effective operation of  
33 DOES for the Executive to be permitted to hire external persons into the Computer Monitor Aide  
34 positions, at an hourly rate not to exceed \$12.49, the minimum rate of pay; and

36 WHEREAS, this Council has determined, after reviewing all pertinent information, that it  
37 is necessary and in the best interest of the County of Summit to authorize the County Executive  
38 to hire two external persons into the part-time, bargaining, classified Computer Monitor Aide  
39 positions at DOES, at an hourly rate not to exceed \$12.49, the minimum rate of pay;

41 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
42 State of Ohio, that:

46 County Council hereby determines that the County Executive has demonstrated that it is  
47 necessary for the effective and continued operation of the Executive's Department of  
48 Environmental Services ("DOES") to authorize the Executive, pursuant to Section 169.04(j) of  
49 the Codified Ordinance, to hire two external persons into part-time, bargaining, ~~unclassified~~  
50 classified Computer Monitor Aide positions at DOES, at an hourly rate not to exceed \$12.49, the  
51 minimum rate of pay.

SECTION 2

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.
