7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Clerk of Courts to**  
9 **hire, either externally or internally, from a non-General Fund funded County position,**  
10 **three persons into the full-time, classified, non-bargaining position of Clerk 3, at the rate of**  
11 **\$13.98 per hour, the minimum pay rate for the position, for the Clerk of Courts, and**  
12 **declaring an emergency.**

13  
14 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted  
15 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled  
16 "Temporary Hiring Freeze," as a budgetary control measure; and

17  
18 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
19 the filling of an existing position by hiring an employee is necessary for the effective and  
20 continued operation of the office, Council may adopt a Resolution authorizing the office to hire  
21 said employee; and

23 WHEREAS, three openings in the full-time, classified, non-bargaining position of Clerk  
24 3 in the County Clerk of Courts' Office have become vacant due to one employee retiring, one  
25 employee transferring to County Council and one employee resigning; and

26  
27 WHEREAS, the Clerk of Courts proposes to hire, either externally or internally, from a  
28 non-General Fund funded County position, three persons into the full-time, classified, non-  
29 bargaining position of Clerk 3, at the rate of \$13.98 per hour, the minimum pay rate for the  
30 position; and

32 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
33 necessary and in the best interest of the County of Summit to authorize the Clerk of Courts to  
34 hire, either externally or internally, from a non-General Fund funded County position, three  
35 persons into the full-time, classified, non-bargaining position of Clerk 3, at the rate of \$13.98 per  
36 hour, the minimum pay rate for the position;

38 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

43 County Council hereby determines that it is necessary for the continued and effective  
44 operation of the County Clerk of Courts' Office, and further authorizes the Clerk of Courts to  
45 hire, either externally or internally, from a non-General Fund funded County position, three  
46 persons into the full-time, classified, non-bargaining position of Clerk 3, at the rate of \$13.98 per  
47 hour, the minimum pay rate for the position.

SECTION 2

This Resolution is hereby declared to be an emergency in the interest of the health, safety and welfare of the citizens of the County of Summit and for the further reason that it is necessary to immediately authorize the Clerk of Courts to hire three persons into the full-time, classified, non-bargaining position of Clerk 3.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect and be in force at the earliest time provided by law.

SECTION 4

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with legal requirements, including Section 121 .22 of the Ohio Revised Code.


