7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**  
9 **two external persons into the full-time, unclassified, non-bargaining position of Attorney 1,**  
10 **up to the midpoint of the pay range, for the Prosecutor, and declaring an emergency.**

11  
12 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted  
13 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled  
14 "Temporary Hiring Freeze," as a budgetary control measure; and

15  
16 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
17 the filling of an existing position by hiring an employee is necessary for the effective and  
18 continued operation of the office, Council may adopt a Resolution authorizing the office to hire  
19 said employee; and

20  
21 WHEREAS, two positions in the full-time, unclassified, non-bargaining position of  
22 Attorney 1 in the County Prosecutor's Office have become vacant due to employees resigning  
23 from the County; and

24  
25 WHEREAS, the County Prosecutor proposes to hire two external persons into the full-  
26 time, unclassified, non-bargaining position of Attorney 1, up to the midpoint of the pay range;  
27 and

29 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
30 necessary and in the best interest of the County of Summit to authorize the County Prosecutor to  
31 hire two external persons into the full-time, unclassified, non-bargaining position of Attorney 1,  
32 up to the midpoint of the pay range;

34 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
35 that:

39 County Council hereby determines that it is necessary for the continued and effective  
40 operation of the County Prosecutor's Office, and further authorizes the County Prosecutor to hire  
41 two external persons into the full-time, unclassified, non-bargaining position of Attorney 1, up to  
42 the midpoint of the pay range.

46 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
47 and welfare of the citizens of the County of Summit and for the further reason that it is necessary  
48 to immediately authorize the hiring of said position for the effective operation of the office.
