7 **A Resolution confirming an award by the Board of Control of a renewal (first of five) of a**
8 **professional service contract with Dr. Norman R. Johnson, aka Advanced Correctional**
9 **Healthcare, for jail inmate medical services, for the period 1/1/12 to 12/31/12, and an**
10 **amendment of the jail population to 620, in an amount not to exceed \$1,837,722.62, for the**
11 **Sheriff, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 2, 2011, awarded a
14 contract to provide the aforementioned services, subject to confirmation by County Council; and,

16 WHEREAS, County Council has determined by reviewing all pertinent information that
17 the contract is necessary and in the best interest of the County of Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a renewal (first of five) of a professional service
25 contract with Dr. Norman R. Johnson, aka Advanced Correctional Healthcare, for jail inmate
26 medical services, for the period 1/1/12 to 12/31/12, and an amendment of the jail population to
27 620, in an amount not to exceed \$1,837,722.62, is hereby confirmed and the County Executive is
28 hereby authorized to execute such contract.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further purpose to immediately
34 provide the aforementioned services.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
46 deliberations of this Council and of any of its committees that resulted in such formal action,

48 121.22 of the Ohio Revised Code.
