7 **An amended Resolution confirming an award by the Board of Control of a renewal (first of**
8 **four) of a lease with Akron First Church of Christ, Scientist, for 30 parking spaces located**

14 contract to provide the aforementioned lease, subject to confirmation by County Council; and,

24 The award by the Board of Control of a renewal (first of four) of a lease with Akron First
25 Church of Christ, Scientist, for 30 parking spaces located at 90 North Summit Street, Akron,
26 Ohio 44308, on a month-to-month basis for a period of one-year, for the period from 12/1/11 to
27 11/30/12, in an amount not to exceed \$1,800.00, is hereby confirmed and the County Executive
28 is hereby authorized to execute such lease.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further purpose to immediately
34 authorize the renewal of provide the aforementioned necessary lease because the current lease
35 will expire on 12/1/11.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
