8 **Everbridge for a service agreement for the public emergency notification and warning**
9 **system in Summit County, for the period 2/1/12 to 1/31/13, under Federal General Services**
10 **Administration Pricing, in an amount not to exceed \$49,000.00, for the Executive's**
11 **Department of Law, Insurance and Risk Management – Division of Public**

14 WHEREAS, the Board of Control, at its meeting held November 16, 2011, awarded a
15 purchase order for a service agreement for the public emergency notification and warning system
16 in Summit County, for the period 2/1/12 to 1/31/13, under Federal General Services
17 Administration Pricing, in an amount not to exceed \$49,000.00, subject to confirmation by
18 County Council; and,

20 WHEREAS, County Council finds and determines, after reviewing all pertinent
21 information, that the aforementioned purchase order is necessary and in the best interest of the
22 County of Summit;

29 The award by the Board of Control of a purchase order with Everbridge for a service
30 agreement for the public emergency notification and warning system in Summit County, for the
31 period 2/1/12 to 1/31/13, under Federal GSA Pricing, in an amount not to exceed \$49,000.00, is
32 hereby confirmed and the County Executive is hereby authorized to execute such purchase order.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and
37 welfare of the citizens of the County of Summit, and for the further purpose of authorizing a
38 necessary purchase order for a service agreement for the County's public emergency notification
39 and warning system, during the period of the Fiscal Year 2010 Metropolitan Medical Response
40 Grant System Program.
