A Resolution authorizing the County Executive to enter into a three-year policing agreement with the Akron-Canton Regional Airport, Council District 8, to provide ten Sheriff's Deputies, for the period 1/1/12 through 12/31/14, in an amount not to exceed \$2,767,565.48, for the Sheriff, and declaring an emergency.

WHEREAS, this Council previously adopted Resolution No. 2009-159, which authorized the County Executive to enter into a policing agreement with the Akron-Canton Regional Airport to provide ten Sheriff's Deputies, for the period 1/1/09 through 12/31/11, in an amount not to exceed \$848,010.80 for the first year, \$881,752.24 for the second year and \$917,193.56 for the third year, for a total amount not to exceed \$2,646,956.60 during the three-year term of the agreement; and

WHEREAS, the aforementioned agreement expires 12/31/11; and

WHEREAS, the Akron-Canton Airport hereby requests that the County Executive enter into a new agreement to provide ten Sheriff's Deputies for the period 1/1/12 through 12/31/14; and

WHEREAS, the Akron-Canton Airport has agreed to pay the County \$912,733.48 for the first year, \$924,355.04 for the second year and \$930,476.96 for the third year, for a total amount not to exceed \$2,767,565.48 during the three-year term of agreement; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that authorizing the Executive to execute the aforementioned agreement is necessary and in the best interest of the County of Summit;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that;

SECTION 1

The County Executive is hereby authorized to enter into a policing agreement with the Akron-Canton Regional Airport, Council District 8, to provide ten Sheriff's Deputies, for the period 1/1/12 through 12/31/14, in an amount not to exceed \$912,733.48 for the first year, \$924,355.04 for the second year, and \$930,476.96 for the third year, in a total amount not to exceed \$2,767,565.48 during the three-year term of the agreement.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety, and welfare of the citizens of the County of Summit and for the further purpose of immediately providing necessary policing for the Akron-Canton Regional Airport for 2012 through 2014.

SECTION 3




