7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept the award by the Ohio Department of Public Safety of a Paul Coverdell National**  
9 **Forensic Sciences Improvement Act of 2000 funding, for the Pathologist and Death**  
10 **Investigator Training grant, in the amount of \$7,129.39, with no local cash match**  
11 **requirement, for the period 10/1/11 through 9/30/12, and appropriating these funds for the**  
12 **period 1/1/12 through 9/30/12, for the Medical Examiner, and declaring an emergency.**

14 WHEREAS, the County Medical Examiner has received a Coverdell Pathologist and  
15 Death Investigator Training grant award from the Ohio Department of Public Safety ("ODPS"),  
16 for the period 10/1/11 through 9/30/12, in the amount of \$7,129.39, with no local cash match  
17 requirement; and

19 WHEREAS, this funding will provide for travel, training, and conference expenses to  
20 various venues including the American Academy of Forensic Sciences Conference, the Death  
21 Investigator Training Course in St. Louis, and an Expert Witness workshop in Naples, Florida;

24 WHEREAS, this Council find and determines, after reviewing all pertinent information,  
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
26 execute any documents necessary to accept the award of the aforementioned grant from ODPS,  
27 and to appropriate these grant funds;

34 The County Executive is hereby authorized to execute any documents necessary to accept
