7 **A Resolution confirming an award by the Board of Control of a purchase order with SHI**  
8 **International Corporation for 120 licenses for Microsoft Office Pro Plus 2010 and one DVD**

10 **amount not to exceed \$38,427.00, for the Prosecutor, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held November 30, 2011, awarded a  
13 purchase order with SHI International Corporation for 120 licenses for Microsoft Office Pro Plus  
14 2010 and one DVD for installation, under State Term Pricing, approved by the IT Board  
15 11/22/11, in an amount not to exceed \$38,427.00, subject to confirmation by County Council;

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
19 that the aforementioned purchase order is necessary and in the best interest of the County of  
20 Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

27 The award by the Board of Control of a purchase order with SHI International  
28 Corporation for 120 licenses for Microsoft Office Pro Plus 2010 and one DVD for installation,  
29 under State Term Pricing, approved by the IT Board 11/22/11, in an amount not to exceed  
30 \$38,427.00, is hereby confirmed and the County Executive is hereby authorized to execute such  
31 purchase order.

35 This Resolution is hereby declared an emergency in the interest of the health, safety and  
36 welfare of the citizens of the County of Summit, and for the further purpose of immediately  
37 authorizing a necessary purchase order for software licenses and a DVD for installation.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take  
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating  
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all  
49 deliberations of this Council and of any of its committees that resulted in such formal action,

51 121.22 of the Ohio Revised Code.

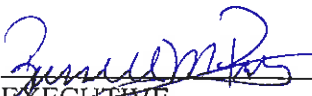
