12 WHEREAS, Resolution No's. 2011-368 and 2011-430 have approved Workforce
13 Investment Act ("WIA") awards to the Youth Employment for Success ("YES") Program for a
14 year-round youth employment program for the State Fiscal Year ending 6/30/12; and

16 WHEREAS, unexpended funds remain in the YES Program at calendar year end 2011
17 that must be appropriated through 6/30/12; and

19 WHEREAS, the youth employment program's objectives are to assist youth in
20 overcoming barriers and achieving academic and career goals by addressing their needs for a
21 work experience, academic support, leadership development, personal guidance, and follow-up
22 services; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to appropriate the
26 aforementioned funds, in the amount of \$128,500.00;

14 be in force at the earliest time provided by law.


