7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept a Fiscal Year 2011 State Criminal Alien Assistance Program grant award from the**
9 **United States Department of Justice, Bureau of Justice Assistance, in the amount of**
10 **\$11,833.00, with no local cash match requirement, and appropriating these funds for**
11 **expenditures in 2012, for the Executive's Department of Law, Insurance and Risk**
12 **Management - Division of Public Safety, and declaring an emergency.**

14 WHEREAS, through the State Criminal Alien Assistance Program ("SCAAP") passed by
15 Congress, the United States Department of Justice, Bureau of Justice Assistance, annually grants
16 funding to states and localities for incarcerating undocumented criminal aliens with at least one
17 felony or two misdemeanor convictions and who are incarcerated for at least four consecutive
18 days; and

20 WHEREAS, SCAAP grant funding may only be used for correctional purposes such as
21 certain construction, certain training and/or education for offenders, specialized training or
22 wages for corrections officers, consultants involved with the offender population, and/or pre-
23 release/reentry programs; and

25 WHEREAS, the United States Department of Justice, Bureau of Justice Assistance, has
26 awarded Summit County a Fiscal Year 2011 SCAAP grant in the amount of \$11,833.00, with no
27 local cash match requirement; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
31 execute any documents necessary to accept the award of the aforementioned grant from the
32 Department of Justice;

34 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
35 of Ohio, that:

39 The County Executive is hereby authorized to execute any documents necessary to accept
40 the Fiscal Year 2011 State Criminal Alien Assistance Program ("SCAAP") award from the
41 United States Department of Justice, Bureau of Justice Assistance, in the amount of \$11,833.00,
42 with no local cash match requirement.

33 121.22 of the Ohio Revised Code.


