7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Sheriff to externally**  
9 **hire a part-time classified Support Services Administrator, at the rate of \$24.36 per hour,**  
10 **the minimum pay rate for the position, for the Sheriff, and declaring an emergency.**

11  
12 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted  
13 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled  
14 "Temporary Hiring Freeze," as a budgetary control measure; and

15  
16 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
17 the filling of an existing position by hiring an employee is necessary for the effective and  
18 continued operation of the office, Council may adopt a Resolution authorizing the office to  
19 externally hire said employee; and

20  
21 WHEREAS, an employee of the County Sheriff serving in the part-time classified  
22 position of Support Services Administrator is retiring; and

23  
24 WHEREAS, the Sheriff proposes to externally hire a part-time classified Support  
25 Services Administrator, at the rate of \$24.36 per hour, the minimum pay rate for the position to  
26 replace the retiring employee; and

28 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
29 that it is necessary and in the best interest of the County of Summit to authorize the County  
30 Sheriff to externally hire a part-time classified Support Services Administrator, at the rate of  
31 \$24.36 per hour, the minimum pay rate for the position;

33 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
34 that:

38 County Council hereby determines that it is necessary for the continued and effective  
39 operation of the County Sheriff's Office, and further authorizes the Sheriff, to hire externally a  
40 part-time classified Support Services Administrator, at the rate of \$24.36 per hour, the minimum  
41 pay rate for the position.

45 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
46 and welfare of the citizens of the County of Summit and for the further reason that it is necessary  
47 to immediately authorize the Sheriff to externally hire a part-time classified Support Services  
48 Administrator to replace a retiring employee.
