7 **A Resolution authorizing the County Executive to execute an agreement with Portage**  
8 **County for back-up plumbing inspection services, to be provided upon request by either**  
9 **county, at a rate of \$71.53, plus mileage and business expenses, commencing on 1/1/12, for**  
10 **the Executive's Department of Economic Development, Division of Building Standards,**  
11 **and declaring an emergency.**

13 WHEREAS, both Summit County and Portage County are charged with the enforcement  
14 of plumbing rules and regulations and have employed certified plumbing inspectors; and  
15

16 WHEREAS, both counties need part-time occasional certified plumbing inspectors to  
17 supplement full-time certified employees by reason of their employees being on sick leave or  
18 vacation; and  
19

20 WHEREAS, it is most cost effective for each county to use neighboring agencies  
21 personnel for back-up plumbing inspection services; and  
22

23 WHEREAS, Summit County and Portage County have agreed to execute an agreement  
24 pursuant to which each county will provide the other with back-up plumbing inspection services  
25 at a rate of \$71.53, plus mileage and business expenses, commencing on 1/1/12; and  
26

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
28 that it is necessary and in the best interest of the County of Summit to authorize the County  
29 Executive to execute an agreement with Portage County for back-up plumbing inspection  
30 services, to be provided upon request by either county, at a rate of \$71.53, plus mileage and  
31 business expenses, commencing on 1/1/12;

33 NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the County of  
34 Summit, State of Ohio, that:

38 The County Executive is hereby authorized to execute to execute an agreement with  
39 Portage County for back-up plumbing inspection services, to be provided upon request by either  
40 county, at a rate of \$71.53, plus mileage and business expenses, commencing on 1/1/12. A copy  
41 of the agreement is attached hereto as Exhibit A and incorporated herein as if fully restated.

45 This Resolution is hereby declared to be an emergency measure in the interest of the  
46 health, safety and welfare of the citizens of the County of Summit, Ohio, and for the further  
47 reason that it is immediately necessary to authorize the Executive to execute the back-up  
48 plumbing inspection services agreement with Portage County, which is to commence on 1/1/12.
