7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the County Prosecutor to hire**  
9 **one external person into the full-time, unclassified, non-bargaining position of Attorney 1,**  
10 **up to the midpoint of the pay range, which is \$24.40 per hour, the Prosecutor, and**  
11 **declaring an emergency.**

12  
13 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted  
14 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled  
15 "Temporary Hiring Freeze," as a budgetary control measure; and

16  
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
18 the filling of an existing position by hiring an employee is necessary for the effective and  
19 continued operation of the office, Council may adopt a Resolution authorizing the office to hire  
20 said employee; and

21  
22 WHEREAS, a full-time, unclassified, non-bargaining position of Attorney 1 in the  
23 County Prosecutor's Office has become vacant due to an employee resigning from the County;  
24 and

26 WHEREAS, the County Prosecutor proposes to hire one external person into the full-  
27 time, unclassified, non-bargaining position of Attorney 1, up to the midpoint of the pay range,  
28 which is \$24.40 per hour; and

30 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
31 that it is necessary and in the best interest of the County of Summit to authorize the County  
32 Prosecutor to hire one external person into the full-time, unclassified, non-bargaining position of  
33 Attorney 1, up to the midpoint of the pay range, which is \$24.40 per hour;

35 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,  
36 that:

38 SECTION 1

40 County Council hereby determines that it is necessary for the continued and effective  
41 operation of the County Prosecutor's Office, and further authorizes the County Prosecutor to hire  
42 one external person into the full-time, unclassified, non-bargaining position of Attorney 1, up to  
43 the midpoint of the pay range, which is \$24.40 per hour.

45 SECTION 2

47 This Resolution is hereby declared to be an emergency in the interest of the health, safety  
48 and welfare of the citizens of the County of Summit and for the further reason that it is necessary  
49 to immediately authorize the hiring of one external person into said position for the effective  
50 operation of the Prosecutor's Office.
