**Approve the Political Activity Policy, as drafted by the HRC, be taken to County Council for approval**


Whereas the Human Resource Commission conducted a full discussion of the proposed recommendation and heard testimony from Kasie Pizarro and Debbie Matz:

Whereupon a motion was entered by Pete Kostoff and seconded by Nancy Wilson to approve the above mentioned action for the Human Resource Commission.

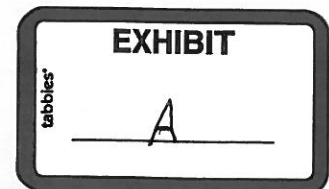


