7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**  
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the Executive to externally hire**  
9 **a full-time classified Plans Examiner, at the a rate not to exceed the midpoint for the**  
10 **position, for the Executive's Department of Community and Economic Development-**  
11 **Division of Building Standards, and declaring an emergency.**

13 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted  
14 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled  
15 "Temporary Hiring Freeze," as a budgetary control measure; and

16  
17 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that  
18 the filling of an existing position by hiring an employee is necessary for the effective and  
19 continued operation of the office, Council may adopt a Resolution authorizing the office to  
20 externally hire said employee; and

22 WHEREAS, as a result of consolidations of the building departments of the City of  
23 Akron, City of Cuyahoga Falls, City of Tallmadge and Village of Silver Lake, along with  
24 increased volume in the commercial construction industry in Summit County, the Division of  
25 Building Standards is in need of an additional Plans Examiner to ensure that submitted  
26 commercial building plans are reviewed and returned in a timely manner; and

28 WHEREAS, the qualifications to serve as a Plans Examiner are such that existing County  
29 employees are not likely to be eligible to apply for the position; and

30  
31 WHEREAS, the Executive proposes to externally hire a full-time classified Plans  
32 Examiner, at the a rate not to exceed the midpoint for the position; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
35 that it is necessary and in the best interest of the County of Summit to authorize the Executive to  
36 externally hire a full-time classified Plans Examiner, at the a rate not to exceed the midpoint for  
37 the position;

39 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

44 County Council hereby determines that it is necessary for the continued and effective  
45 operation of the Executive's Division of Building Standards, and further authorizes the  
46 Executive, to hire externally a full-time classified Plans Examiner, at the a rate not to exceed the

SECTION 2
