12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for a four-year full
16 maintenance service agreement for three passenger elevators in the Ohio Building, in Council
17 District 4, for an estimated total cost not to exceed \$62,000.00; and

19 WHEREAS, a copy of the specifications are on file in the office of the Clerk of Council;

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that is necessary and in the best interest of the County of Summit to authorize the Executive to
24 advertise for bids for the aforementioned project;

31 The County Executive is authorized to advertise for bids for a four-year full maintenance
32 service agreement for three passenger elevators in the Ohio Building, in Council District 4, for
33 an estimated total cost not to exceed \$62,000.00.

37 This Resolution is declared an emergency in the interest of the health, safety, and welfare
38 of the citizens of the County of Summit, and for the further reason that it authorizes the
39 Executive to immediately advertise for bids for the aforementioned elevator maintenance service
40 agreement in order to have a new contract in place when the current contract expires on April 30,
41 2012.
