7 **A Resolution appropriating carryover funds for the Emergency Management Program**
8 **Grant, in the amount of \$47,756.22, and the Hazardous Materials Program, in the amount**
9 **of \$114,445.29, for Fiscal Year 2012, for the Executive's Department of Law, Insurance and**
10 **Risk Management – Public Safety Division/Emergency Management Agency, and declaring**
11 **an emergency.**

13 WHEREAS, the Emergency Management Program Grant ("EMPG") funds are required
14 to support the county-wide emergency management preparedness drills, trainings, and resources,
15 including annual fees associated with WebEOC, and

16
17 WHEREAS, the EMPG funds appropriated in Resolution No. 2011-483 have a remaining
18 cash balance of \$47,756.22 at year end 2011 that must be appropriated through 2012; and

19
20 WHEREAS, the Hazardous Materials Program ("HazMat") receives an allocation from
21 the Emergency Management Agency budget, to support and sustain the Summit County Special
22 Operations Response Teams, Hazmat Branch, Technical Rescue Branch and Water Rescue
23 Branch, throughout Summit County; and

25 WHEREAS, the HazMat funds appropriated in Resolution No. 2011-483 have a
26 remaining cash balance of \$114,445.29 at calendar year end 2011 that must be appropriated
27 through 2012; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that it is necessary and in the best interest of the County of Summit to appropriate the two
31 aforementioned funds, in the amount of \$47,756.22 and \$114,445.29;

33 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
34 of Ohio, that:

28 121.22 of the Ohio Revised Code.


