7 **A Resolution authorizing the County Executive to advertise for bids for the Ohio**
8 **Building/Safety Building heating, ventilation and air conditioning system upgrade project,**
9 **in Council District 4, for an estimated total cost not to exceed \$1,050,000.00, for the**
10 **Executive's Department of Administrative Services, and declaring an emergency.**

12 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
13 requires this Council's authorization for the County Executive to advertise for bids; and

15 WHEREAS, the County Executive wishes to advertise for bids for the Ohio
16 Building/Safety Building heating, ventilation and air conditioning system upgrade project, in
17 Council District 4, for an estimated total cost not to exceed \$1,050,000.00; and

19 WHEREAS, a copy of the specifications are on file in the office of the Clerk of Council;

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that is necessary and in the best interest of the County of Summit to authorize the Executive to
24 advertise for bids for the aforementioned project;

27 of Ohio, that;

31 The County Executive is authorized to advertise for bids for the Ohio Building/Safety
32 Building heating, ventilation and air conditioning system upgrade project, in Council District 4,
33 for an estimated total cost not to exceed \$1,050,000.00.

37 This Resolution is declared an emergency in the interest of the health, safety, and welfare
38 of the citizens of the County of Summit, and for the further reason that it authorizes the
39 Executive to immediately advertise for bids for the Ohio Building/Safety Building heating,
40 ventilation and air conditioning system upgrade project to permit the project to proceed as soon
41 as possible.

46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
