7 **A Resolution confirming an award by the Board of Control of a purchase order with**
8 **Serpentini Chevrolet – Montrose Auto Group for one 2012 Chevrolet Caprice four-door**
9 **police patrol vehicle, under CUE pricing, in an amount not to exceed \$27,262.77, for the**
10 **Sheriff, and declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held February 29, 2012, awarded a
13 purchase order to provide one 2012 Chevrolet Caprice four-door police patrol vehicle, under
14 CUE pricing, in an amount not to exceed \$27,262.77, subject to confirmation by County
15 Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the purchase order is necessary and in the best interest of the County of Summit;

20 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

25 The award by the Board of Control of a purchase order with Serpentini Chevrolet –
26 Montrose Auto Group for one 2012 Chevrolet Caprice four-door police patrol vehicle, under
27 CUE pricing, in an amount not to exceed \$27,262.77, is hereby confirmed and the County
28 Executive is hereby authorized to execute such purchase order.

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the citizens of the County of Summit, and for the further reason to immediately
34 provide the aforementioned vehicle for the Sheriff.

38 Provided this Resolution receives the affirmative vote of eight members, it shall take
39 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
40 effect and be in force at the earliest time provided by law.

45 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
