7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with the County of Summit Sheriff's Office for the IV-D provider contract for**
9 **process services, for the period 1/1/12 through 12/31/12, in an amount not to exceed**
10 **\$289,747.65, for the Prosecutor – Child Support Enforcement Agency, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held February 15, 2012, awarded a
14 professional service contract with the County of Summit Sheriff's Office for the IV-D provider
15 contract for process services, for the period 1/1/12 through 12/31/12, in an amount not to exceed
16 \$289,747.65, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned contract is necessary and in the best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a professional service contract with the County of
27 Summit Sheriff's Office for the IV-D provider contract for process services, for the period 1/1/12
28 through 12/31/12, in an amount not to exceed \$289,747.65, is hereby confirmed and the County
29 Executive is hereby authorized to execute such contract.

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the citizens of the County of Summit, and for the further purpose of immediately
35 providing these services for the period beginning 1/1/12.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,
