7 **A Resolution, pursuant to Section 169.04(j) of the Codified Ordinances of the County of**
8 **Summit, entitled "Temporary Hiring Freeze," to authorize the Internal Audit Committee**
9 **to hire one external person into the full-time, unclassified, non-bargaining position of**
10 **Deputy Director, up to the midpoint of the pay range, which is \$34.45 per hour, and to hire**
11 **one external person into the full-time, unclassified non-bargaining position of Internal**
12 **Auditor 1, up to the amount of \$19.23 per hour, for the Internal Audit Department, and**
13 **declaring an emergency.**

15 WHEREAS, pursuant to Resolution No. 2009-110 and 2011-204, this Council enacted
16 and extended Section 169.04(j) of the Codified Ordinances of the County of Summit, entitled
17 "Temporary Hiring Freeze," as a budgetary control measure; and

18
19 WHEREAS, Section 169.04(j) provides that if a County office is able to demonstrate that
20 the filling of an existing position by hiring an employee is necessary for the effective and
21 continued operation of the office, Council may adopt a Resolution authorizing the office to hire
22 said employee; and

24 WHEREAS, the full-time, unclassified, non-bargaining position of Deputy Director in
25 the Internal Audit Department will become vacant due to an employee transferring to the Summit
26 County Board of Developmental Disabilities; and

28 WHEREAS, the full-time, unclassified, non-bargaining position of Internal Auditor 1 in
29 the Internal Audit Department will become vacant due to an employee transferring to the Child
30 Support Enforcement Agency; and

32 WHEREAS, the Internal Audit Committee proposes to hire one external person into each
33 of these positions; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that it is necessary and in the best interest of the County of Summit to authorize the Internal
37 Audit Committee to hire one external person for each of the aforementioned positions.

39 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

44 County Council hereby determines that it is necessary for the continued and effective
45 operation of the Internal Audit Department, and further authorizes the Internal Audit Committee
46 to hire one external person into the full-time, unclassified, non-bargaining position of Deputy
47 Director, up to the midpoint of the pay range, which is \$34.45 per hour, and to hire one external
48 person into the full-time, unclassified non-bargaining position of Internal Auditor 1, up to the
49 amount of \$19.23 per hour.

SECTION 2
