7 **A Resolution authorizing the County Executive to execute the First Amendment to the 407**
8 **Community Corrections Program contract with Oriana House, Inc., and the Summit**
9 **County Court of Common Pleas, on behalf of the Adult Probation Department, for State**
10 **Fiscal Year 2012, for the period 7/1/11 through 6/30/12, increasing the contract in the**
11 **amount of \$16,000.00, for a total amount not to exceed \$1,255,107.00, for the Executive's**
12 **Department of Law, Insurance and Risk Management, Division of Public Safety – Justice**
13 **Affairs, and declaring an emergency.**

14
15 WHEREAS, the State of Ohio Department of Rehabilitation and Correction ("ODRC"),
16 through the Community Correction Act ("CCA") Grant Program, previously renewed the award
17 to the County of Summit of a 407 grant for State Fiscal Year ("SFY") 2012, in the amount of
18 \$1,239,107.00, with no local cash match requirement, for community corrections programs to be
19 operated by the County Adult Probation Department and Oriana House, Inc.; and

21 WHEREAS, this Council previously adopted Resolution No. 2011-312, which authorized
22 the Executive to execute a contract with Oriana House, Inc., in the amount of \$899,518.00 and
23 the Summit County Adult Probation Department in the amount of \$339,589.00, for the
24 operations of community corrections programs for SFY 2012 which is funded by the 407 CCA
25 grant award; and

27 WHEREAS, additional ODRC funding has been made available through the SFY 2012
28 CCA 407 grant in the amount of \$16,000.00, with no local cash match requirement, to support
29 bus passes and client rewards for both the Day Reporting and the Reentry Court Programs
30 operated by Oriana House, Inc.; and

32 WHEREAS, it is necessary to authorize the Executive to execute the First Amendment to
33 the 407 Community Corrections Program contract with Oriana House, Inc., to increase the
34 amount of the 407 Community Corrections Program contract with Oriana House, Inc., and the
35 County of Summit Court of Common Pleas, on behalf of the Adult Probation Department, in the
36 amount of \$16,000.00, for a total contract amount of \$1,255,107.00; and

38 WHEREAS, this Council finds and determines, after all pertinent information, that it is
39 necessary and in the best interest of the County of Summit to authorize the County Executive to
40 execute the aforementioned First Amendment to the contract with Oriana House, Inc.;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
43 of Ohio, that:

47 The County Executive is hereby authorized to execute the First Amendment to the 407
48 Community Corrections Act ("CCA") contract with Oriana House, Inc. and the County of
49 Summit Court of Common Pleas, on behalf of the Adult Probation Department, increasing the
50 contract in the amount of \$16,000.00, for a total amount not to exceed \$1,255,107.00.

9 for the stated purpose, within the State Fiscal Year 2012 grant period.

13 Provided this Resolution receives the affirmative vote of eight members, it shall take
14 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
15 effect and be in force at the earliest time provided by law.
