7 **A Resolution confirming an award by the Board of Control for the second renewal of a**
8 **professional service contract with United Safety Advisors, LLC, for special teams planner**
9 **services, as Best Practical Source, for the period 4/1/12 through 3/31/13, in an amount not**
10 **to exceed \$26,000.00, for the Executive's Department of Law, Insurance and Risk**
11 **Management – Division of Public Safety/Emergency Management Agency, and declaring**
12 **an emergency.**

14 WHEREAS, the Board of Control, at its meeting held March 14, 2012, awarded the
15 second renewal of a professional service contract with United Safety Advisors, LLC, for special
16 teams planner services, as Best Practical Source, for the period 4/1/12 through 3/31/13, in an
17 amount not to exceed \$26,000.00, subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the contract renewal is necessary and in the best interest of the County of Summit;

27 The award by the Board of Control for the second renewal of a professional service
28 contract with United Safety Advisors, LLC, for special teams planner services, as Best Practical
29 Source, for the period 4/1/12 through 3/31/13, in an amount not to exceed \$26,000.00, is hereby
30 confirmed and the County Executive is hereby authorized to execute such contract renewal.

34 This Resolution is hereby declared an emergency in the interest of the health, safety and
35 welfare of the citizens of the County of Summit, and for the further purpose of immediately
36 providing these services for the period beginning 4/1/12.

40 Provided this Resolution receives the affirmative vote of eight members, it shall take
41 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
42 effect and be in force at the earliest time provided by law.
